The training is funded by the employer and/or the government which means joining the world of work, building a wealth of knowledge AND experience and not worrying about the prospect of debt.

TECHNICAL APPRENTICESHIPS

Our Technical Apprenticeships have been a successful part of our business for over 50 years and just like the vehicles we work on, our programme is ever evolving to ensure we stay at the forefront of automotive career development.

By working with our training partners City of Bristol College, Skillnet, Babcock, Remit Training and Stephenson College you can be assured that your son or daughter will receive the highest standard of training, which takes place in our own workshops and at college blocks off site – all relative training costs including travel, accommodation, meals, uniform and learning resources are all covered by the business. All we need from our apprentices are enthusiasm, hard-work and commitment.

Aspects of the 3yr apprenticeship programme include:

- Full time employment at an Motus Commercials dealership
- Full support in-house from a dedicated qualified Mentor
- Up to 14 x College Blocks (2 weeks each) at one of our approved college partner sites
- Nationally recognised qualification – Level 3 Heavy / Light Vehicle Technician
- Functional Skills in Maths, English & ICT (unless applicant provides GCSE exemptions at Grade 5/C)

DAF PARTS APPRENTICESHIPS

Our Apprentice Parts Advisors undertake their training in house at their respective Motus Commercial dealerships, through regular remote classroom activities and also block learning at a dedicated training facility in Derby, where they will learn everything they need to know about DAF Trucks and PACCAR Parts.

A dedicated Development Coach will support individuals to work towards a Level 3 Supply Chain Practitioner qualification (over 3 years) whilst ensuring they are fully equipped to support all customers both internal and external to our business. All costs relating to external training are covered by the Motus Commercial.

Other apprenticeships are available in non-technical functions including Business Administration, Sales and Accounting.

REWARD & RECOGNITION

At Motus Commercial we strongly believe in the importance of recognition for all our employees and our apprentices are no different.
